

**Minutes of the Meeting of the Board of Post Graduate Studies in English,
held on 23-11-13 in the office of the head Department of English.**

The meeting was in response to the University directive for restructuring the existing MA Syllabus in accordance with the Choice Based Credit System to be implemented from March 2014 onwards.

The meeting commenced with a welcome address by the chair to all the participants which included members, experts, special invitees - from North and South campus, University of Kashmir, Govt College for Women, M A Road and Amar Singh College, Srinagar.

The Head started by explaining the Choice Based Credit System and also spelt out the objectives of the new scheme. The new scheme has been introduced with a view to generate possibilities of freedom and choice to the students in selecting courses and diverse streams in the university. This provides not only greater inter-disciplinary cooperation and co-ordination but also aims at providing opportunities for greater integrated growth and development of the students.

After a thorough, semester-wise debate and discussion over the proposed courses, the committee approved a selection of Core, Allied and Open electives for the entire MA programme in English.

The meeting ended on a vote of thanks by the chair.

The Board reviewed the current syllabus of M A English and resolved the following:

- That the syllabus needs to be made all-inclusive/comprehensive so that it is in tune with the prolific production of literary texts the world over
- That the students should be exposed to a vast range of literary texts to facilitate their performance in competitive examinations like SET and NET/JRF
- That a list of suggested/recommended reading be provided at the end of the Core Courses and Discipline Centric Electives

The Board was informed that the syllabuses designed by the Board of Under graduate Studies (English) for B A Honours (English) and B A Literature in accordance with the UGC template for these programmes under Choice Based Credit Scheme were all-inclusive/comprehensive and therefore the syllabus at the masters level should be equally updated /standardised when these students join the department of English. It was also resolved that the Generic Electives and Open Electives for students from sister departments and the rest of the departments of the University should be revisited and modified. The Board was of the opinion that most of these students have no background knowledge of English Literature and therefore the electives offered should be accessible and deal with contemporary/relevant issues.
